### Strawberry Shortcake Lasagna

- 4 c. heavy cream; 1/2 c. powdered sugar, plus more for dusting; 2 tsp. pure vanilla extract
- 1 1/2 boxes Nilla Wafers; 1 lb. Strawberries, thinly sliced

In a large bowl using a hand mixer, beat heavy cream, powdered sugar and vanilla until medium peaks form.

In a 9"-x-13" pan, spread a thin layer of whipped cream. Top with a layer of Nilla Wafers and spread a thick layer of whipped cream on top.

Top with a layer of strawberries. Repeat two times, ending with strawberries. Sprinkle with crushed Nilla Wafers.

Refrigerate until Nilla Wafers are totally soft, 3 hours, or up to overnight.

Sprinkle with more powdered sugar, then slice and serve..
